

## University Bursar's Office Information and Notification of a Parent Borrower's Right to Cancel a Federal Direct PLUS Loan

- You are receiving the enclosed check because the current fees for the semester that were outstanding at the time of disbursement have been paid. The amount disbursed is for one semester. Use the remaining funds to assist with your student's expenses throughout the semester.
- If you have questions about what eligible fees were paid by financial aid funds, or if any other monies are due to the university, your student can view that information on their <u>my.SDSU</u> account. Your student may also release information to a third party by submitting an <u>Authorization to Release information</u>.
- San Diego State University policy is to apply financial aid and/or scholarship funds directly to charges for the semester's basic tuition and fees, residence hall charges, and other eligible institutional expenses (including financial aid overpayments) at the time of disbursement. An excess financial aid will be refunded to the student directly via direct deposit (if enrolled) or check.
- You have the right to cancel all or a portion of your loan and have the loan proceeds returned to the holder
  of the loan. If you cancel your loan completely for the fall semester, it automatically cancels the loan for the
  rest of the academic year. If you reduce your loan, then it does not charge your loan amount for the
  following semester. If you wish to cancel or reduce your loan, you have several options described on the
  form below.
- Students are responsible for actively checking their student account for any pending charges not covered by their aid.
